Church Usage \$300
This fee is for the use of either the Sanctuary or the Chapel.

Printed Order of Worship \$50
For up to 100 b/w copies, standard format. Fee may increase in order to accommodate special requests.

Clergy Fee \$400
This is the minimum honorarium as determined by our Trustees in order to compensate our clergy for dedicating their time for the care of your family, by providing a meaningful Christian service and accompanying you to another church or local cemetery for interment, if needed. Additional compensation may be required for time and travel expenses of our clergy if they are asked to accompany you to a cemetery outside of Nassau County.

Organist Fee \$300

Vocal Soloist (optional) \$150

Custodian Fee \$150
This fee is for the set-up and clean-up of either the Sanctuary or the Chapel.

Reception (optional)
If a reception is desired at the church, they are usually no longer than 2 hours. We do not have an in-house catering service. We can set up coffee and tea, but you must arrange for all other food to be delivered and served. (No alcoholic beverages are permitted). Please contact the church office for details.
